ICAR-NBFGR, Lucknow invites expression of interest (EOI) for establishing interpretation centre as a part of its National Museum and Repositories from the firms/architects/artists with expertise in scientific communication. The design and concept can include development of galleries, displaying through combination of models, text and audio visual light effects or any other artistic means applicable. The displays will have broad context of Aquatic Genetic Resources (or Fish Biodiversity) and will be collected as sub themes covering various aspects such as type of Ecosystem, Diversity, Importance, Concerns, International and National Laws related to biological diversity, Fishing methods and Gears, Aquaculture, Trade and Products, Conservation, Repositories, Research structure in India, Institutes and a Laboratory equipments (to be provided by NBFGR) and laid as functional unit with a real time feel, to the visitors especially school children.

The facility is created for public, for educational and awareness purpose and should give live feel of the thematic communication.

The technical part of the themes will be provided by the NBFGR or identified experts. The firm/persons interested to participate in the EOI need to have the capacity to communicate scientific messages to the public visitors.

**Pre-Qualification Criteria**

1. The bidder should be OEM or its authorized agent.
2. The bidder must be well established in the area.
3. In case the bidder is authorized agent of OEM, it should have authorization of full support for maintenance, warranty and spare parts from OEM.
4. The bidder should have successfully executed three similar projects each costing not less than Rs. 20 Lakh, or two projects each costing not less than Rs. 30 Lakh or one project not casting less than Rs. 50 Lakh during the last three financial years..
5. The minimum turnover of the bidder should not be less than 50 Lakh per year during the last three financial years. The annual turnover for OEMs should not be less than Rs. 1 Crore per year during the last three financial years.
6. Letters of reference/completion certificates from past customers should be provided.
7. The bidder should provide a bank solvency certificate for Rs. 50 Lakh
8. Consortiums and Joint Ventures will not be entertained.

9. The OEM of the Firm/Company should have service centre in Lucknow experienced for last 3 years. A single point of contact for maintenance work must be provided.

*The EoI should incorporate the following:*

1. Details of the bidder (OEM)
2. Brief details of similar past projects
3. Audited financial statements for the last three years
4. Solvency certificate from bank
5. Technical proposal
6. Any other information relevant to this project

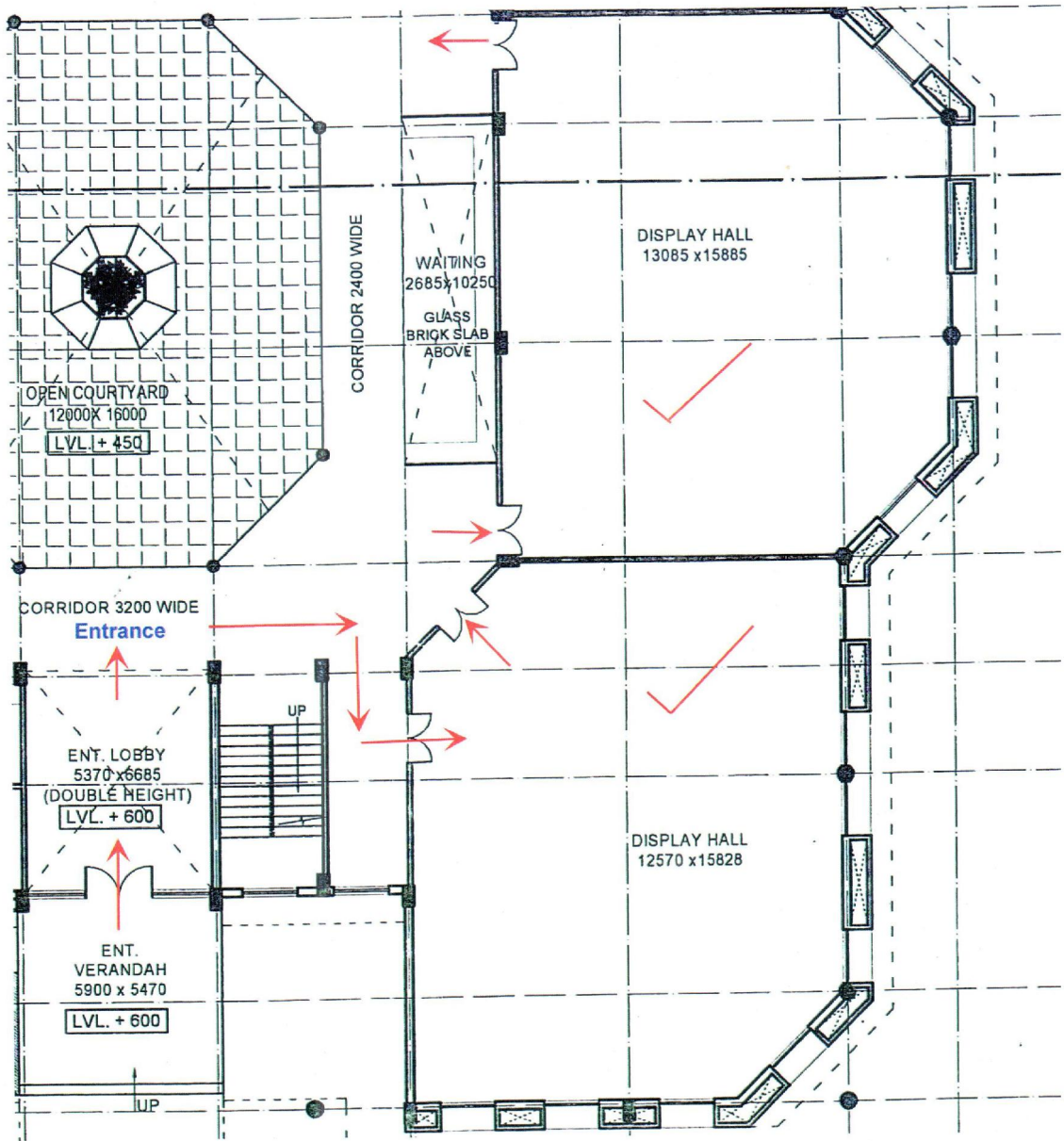
