- 1. The tender shall quote rates, which will include the delivery and other incidental charges, Taxes, if any, should be indicated separately.
- 2. The rates should be quoted as per the BOQ uploaded on the CPP Portal. Taxes, if any, should be indicated separately. If must be noted that the contract shall be awarded to the firm which fulfils all the required terms and conditions and remains L-1 for any particular items.
- 3. The firm must also possess valid PAN No., GSTIN No. and a copy of the same must also be enclose with the tender document.
- 4. Copy of previous three years of Income Tax Statement may be furnished.
- 5. Modification in the tender documents after the closing date is not permissible.
- 6. The successful firm shall have to supply within 45 days from the date of confirmed supply order. The rates quoted shall be valid for one year from the date of opening of tender.
- 7. The contractor/bidder or his representative may contact the undersigned at Telephone No. 0522-2441735, 2440145 for any further clarification.
- 8. The Director, ICAR-National Bureau of Fish Genetic Resources (ICAR-NBFGR) shall have the right to reject all or any of the offers, accept more than one offer, and assign part of the job.
- 9. Merely quoting of lowest rates does not mean that order shall be given to that firm. The Competent Authority will finally decide on the basis of quality and performance of past installation.

INSTRUCTION FOR ONLINE BID SUBMISSION

The bidders are requested to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <u>https://eprocure.gov.in/eprocure/app</u>.

REGISTRATION:

- Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online Bidder Enrolment" on the CPP Portal which is free of charge.
- As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sift / TCS /nCode /eMudhra etc.), with their profile.
- Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC/e-Token.

SEARCHING FOR TENDER DOCUMENTS:

- There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, other keywords etc. to search for a tender published on the CPP Portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

• Bidder should take into account any corrigendum published on the tender document before submitting their bids.

- Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF /XLS /RAR/DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN Card Copy, Annual Reports, Auditor Certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the while coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- The serve time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

<u>Specification for Lab Furniture (With complete installation)</u> <u>Technical Specification Compliance Statement Form</u>

Scope: Furnish, delivery and installation of all laboratory furniture, drains, drain troughs, overflows and sink outlets with integral tailpieces, which occur above the floor, and where these items are part of the equipment as included in Bill of Quantities with reference to provided layout drawing.

- 1. General Performance: Provided SEFA Approved Independent Test Lab certification that furniture shall meet the performance requirements described in SEFA 8M (2016) and SEFA 10 and its Latest version.
- 2. Compete SEFA 8M & SEFA 10 tested 3rd party report by SEFA approved Laboratory to be submitted in advance as a pre-qualification for quoting the tender.
- 3. The bidder needs to have supplied & installed at least 2 projects in India with SEFA tested furniture, each worth at least 25 lakhs with completion certificate within last 5 years. Enclose purchase order copies.

Work Tops:

The worktops shall be of 18 ± 1 mm thick telephonic back Granite of an even surface with level tolerance less than 1 mm. The front edge of the granite shall be chamfered at an angle of 28 degree and smoothened. The back splash for the wall bench shall be of granite 18/19 mm thick material of height 4" from the finished table top level.

Module Casework, wall cabinets, tables and related accessories.

All cabinet bodies shall be flush front construction with intersection of vertical and horizontal case members, such as end panels, top rails, bottoms and vertical posts in same plane without overlap. Exterior corners shall be spot welded with heavy back up reinforcement at exterior corners. All face joints shall be welded and ground smooth to provide a continuous flat plane.

- A. Plinth System: Steel: Cabinet bodies, drawer bodies, shelves, drawer heads and door assemblies shall be fabricated from cold rolled close anneal steel (CRCA Steel). The under bench cabinets will be plinth mounted carrying the cabinets. The worktop will be directly supported by the under-bench cabinets. Legs shall be with adjustment feet \pm 15 mm to correct eventual unevenness of the floor. The C Frame System should be tested and in accordance with SEFA 10.
- **B. Steel:** CRCA Steel grade must comply with ASTM A366. Components must be properly leveled, treated and conditioned to be free of scale or visible imperfections. Material thickness for all gauges must meet the standards. Gauges of steel used in construction of cases shall be 18 gauges, except as follows:

- 1. Cabinet shall be fabricated from a complete formed 14 gauge top frame flanged and welded to case body all four sides. Table aprons and reinforcement gussets shall be 14 gauge.
- 2. Vertical support uprights shall be 14 gauge.
- 3. Bottom case shall be full width 14 gauge sub bottom, double formed and fabricated to 11 gauge equivalent, welded to case body understructure and reinforced with 3/8-16 threaded weld nuts as level receivers.
- 4. Shelves shall be 16 gauge. A hat channel reinforcement will be added for any unit 36" or over in width.
- 5. Drawer suspension channels shall be 14 gauges.
- 6. Drawer assemblies and door assemblies shall be 20 gauge.
- 7. Hinge reinforcement of 14 gauge steel shall be provided.
- **C. Base cabinets:** Shall be constructed to support a uniformly distributed load of minimum 100 kg (± 10) per square foot (1000 kg/m²) of cabinet top area including working surface without objectionable distortion or interference with door and drawer operation.
